**Specifications and Terms & Conditions:**

1. Burning Capacity of Incinerator – 20 Kg/ Day
2. Material to be used for Incinerator – GI Sheet
3. The exhaust pipe from incinerator should have at least 6 Meter height (GI Sheet/ GP Sheet).
4. Incinerator should have minimum 300°C heat resistance.
5. Incinerator should have minimum one year guarantee.
6. The firm/contractor should arrange all labourers, vehicles etc. to bring and install Incinerator at HOC Township, Irumpanam at their own cost and risk.
7. The Incinerator should be installed at HOC Township, Irumpanam within 15 days on receipt of the Order.
8. The payment will be made within 10 days after installation.
9. If the installed Incinerator is found defective, it should be replaced immediately as per the directions from HOCL.
