



#### **ANNEXURE-I**

#### **GENERAL TERMS AND CONDITIONS OF THE TENDER**

#### EMD - Nil

#### **RATES**

Rates quoted shall be inclusive of all taxes, duties, octroi and other levies etc. GST, in case applicable shall be paid extra. The bidder should have GST registration with Central Excise Department.

#### **PERFORMANCE SECURITY**

#### PERIOD OF CONTRACT

The period of the contract shall be **6 Months** from the date of issue of work order / issue of instruction to start the work.

## **SCOPE OF SUPPLY**

#### **Materials**

#### a. HOCL's Scope

- 1. HOCL shall issue bed materials, gaskets, fasteners, air, water, electricity at one point free of cost to the contractor.
- 2. HOCL shall provide only the gasket sheets (CAF) (free of cost) to the contractor. The contractor has to make arrangements to cut the gaskets to the required size.
- 3. Fasteners (if required) for the final box up work shall be issued by HOCL at free of cost.

#### b. Contractor's Scope

 Scaffolding material (pipe, clamps and base plates) and its erection if required shall be arranged by the contractor.

#### **Tools and Tackles**

#### a. Contractor's Scope

- 1. All skilled & Unskilled manpower require for the work is to be arranged by the contractor. All machines, tools, tackles, lifting equipments such as crane, chain pulleys, slings, D shackles, other tools and equipments required for the satisfactory completion of the work is to be arranged by the contractor.
- 2. CRANE / DERRICK required for the successful completion of the entire work shall be arranged by the contractors at his own cost. HOCL shall permit the contractor to hire the HOCL's mobile crane/Forklift on chargeable basis, if it is available and the rate shall be ₹1000/hr. + GST for mobile crane of capacity 18T and ₹600/hr. + GST for Forklift of 3T Capacity.



- 3. Suitable vehicle for shifting PSF (7.7 Meter length, 2.4 Meter Dia, 7.1 MT weight) and Back wash water storage tank (8 Meter length, 3 Meter Dia, 4 MT weight) shall be arranged by the contractor.
- 4. Scaffolding material (pipe, clamps and base plates) and its erection if required shall be arranged by the contractor.

# b. HOCL's Scope

#### **General Site Cleaning**

Working site should always be kept cleaned upto the entire satisfaction of the Engineer/Officer-In-Charge. Upon completion of the work, all materials shall be transported to designated locations in HOCL premises as directed by the Engineer/Officer-In-Charge on daily basis. Material reconcilliation has to be carried out before submitting the bill.

#### **TIME OF COMPLETION**

Time of completion shall be within 15 day from the date of instruction to start the work.

#### **VALIDITY OF THE TENDER**

The tender shall be kept valid for acceptance for a period of **THREE months** from the last date prescribed for receipt of the tender.

A Tenderer shall not be entitled during the said period of three months without the consent in writing of the company to revoke or cancel his tender or to vary the tendered rate or any terms thereof.

# **PRICE**

The Contract will be awarded on fixed all-inclusive price unless otherwise specified. All rates in the tender shall cover applicable taxes, levies and duties. However applicable GST will be paid by HOCL subject to the successful tenderer having GST registration with Central Excise.

The price shall be quoted both in figures and words. In case a tenderer has quoted two different prices in words and figures the lower of the two will be considered valid and binding on the tenderer.

# **PAYMENT TERMS**

100% payment will be made within 30 days after completion of work and certified by Engineer-in-Charge.

# **CONTRACT PREFERENCE**

Contract / Price Preference or any other concessions applicable for **MSME / SSI Units /PSUs** will be as per latest Government of India Directives. For availing this benefit, the bidder shall make their claim in the Technical Bid itself and enclose necessary documentary evidence to prove their eligibility.



ANNEXURE-II

#### **SCOPE OF WORK**

This works includes disconnection and shifting of Vessel/Tank from PTP to Cooling Tower. Unloading of PSF bed material segregation & shifting the same to Cooling Tower. Refilling of bed material after installation of PSF on the new foundation.

#### The scope of work includes, but not confined to the following-

# **Pressure Sand Filter (PSF)**

- Dismantling and blinding of interconnected piping & valves of PSF as per the instruction of Engineer-In-Charge.
- Opening of all man-way after getting instruction of engineer -in-charge.
- After receipt of man entry permit and positioning of a standby person at the man-way, Man entry through shell man-way.
- Unloading of bed material & segregation of the same.
- Shifting of empty PSF and segregated bed materials separately to Cooling Tower.
- Installation of PSF on new foundation at Cooling Tower.
- After inspection of PSF internals, cleaning and refilling of bed material shall be done as per the instruction of Engineer-In-Charge.
- Bed material shall be filled as per the designed level instructed by engineer-in-charge. Balance material if available to be segregate and stored at location as per the instruction of engineer -in-charge.
- Manway shall be boxed up with new gasket after completion and refilling.

#### **Back Wash Water Storage Tank**

- Dismantling and blinding of interconnected piping & valves of Back Wash Water Storage Tank as per the instruction of Engineer-In-Charge.
- Shifting of Back Wash Water Storage Tank along with required disconnected piping and valves to Cooling Tower.
- Installation of Back Wash Water Storage Tank on new foundation at Cooling Tower.

#### **General Scope**

- Suitable Crane & vehicle required for shifting the Vessel, Tank & Bed martials shall be arranged by the contractor at his own cost. PSF empty weight is around 7.1 MT & Back wash storage tank empty weight is around 4 MT. HOCL shall permit the contractor to hire the HOCL's mobile crane/Forklift on chargeable basis, if it is available and the rate shall be ₹1000/hr. + GST for mobile crane of capacity 18T and ₹600/hr. + GST for Forklift of 3T Capacity.
- Necessary scaffolding shall be provided by the contractor if required for satisfactory completion of the work.
- All tools, tackles, all consumables, PPEs, shall be brought by the contractor at his cost.
- HOC will provide power, air and water at one point.
- All the skilled and unskilled labours required for the job shall be arranged by the contractor.
- The contractor employees shall use all necessary PPEs while working inside the plant and the same is under the scope of Contractor.
- All wastes, debris arising out of the job shall be segregated, weighed and dumped in the scrap yard as per the instruction of Engineer-in-Charge.
- Housekeeping is to be done after completion of all jobs as per the instruction from Engineer in charge.



- 2. GCC duly filled in the relevant portions, signed and stamped all the pages by the tenderer (The tenderers have to download the GCC (General Conditions of Contract) from our web site www.hoclkochi.com and the same has to be returned along with the technical bid duly signed and stamped in all pages.
- 3. Tender should accompany the details asked in A, B, C, D, E, H, R, S & AC.
- 4. Experience on similar works executed during the last five years and details like monetary value, proof of satisfactory completion of works etc.
- 5. Organization chart giving details of field management at SITE, the tenderer proposes to have for this work including bio-data of the Site-in Charge and key personnel
- 6. The bidder should have well qualified workforce in adequate numbers for handling various stages of the work. The staff/workers details are to be furnished.
- 7. In the case of MSME, necessary certificate (self attested) shall be submitted in the Technical Bid.
