ANNEXURE-I

GENERAL TERMS AND CONDITIONS OF THE TENDER

EMD - ₹40,100/- (Not applicable to NSIC / SSI / MSME/PSU) shall be paid by through NEFT/RTGS & Bank Guarantee.

EMD of the tenderer will be forfeited under the following conditions:-

- 1. If after opening of the tender, the tenderer revokes his tender or increase his quoted rates.
- 2. If the tenderer does not commence the work after awarding the contract.
- 3. No interest on EMD will be paid.
- 4. EMD of the successful tenderer will be adjusted against the security deposit.
- 5. EMD of unsuccessful bidders shall be refunded after finalization of the contract and no interest shall be payable.
- 6. The tender is revoked or varied during its validity period.
- 7. The Prices are increased unilaterally after the tender opening and during its validity.
- 8. The tenderer after intimation of acceptance of the tender fails to execute the agreement/or furnish security deposit within the stipulated time.

Pre-qualification Criteria

- Complete set of Tender Document duly filled in and signed by the Tenderer as prescribed in different clauses of the Tender Document.
- GCC duly filled in the relevant portions, signed and stamped all the pages by the tenderer (The tenderers have to download the GCC (General Conditions of Contract) from our web site <u>www.hoclkochi.com</u> and the same has to be returned along with the technical bid duly signed and stamped in all pages.

Pre-qualification Criteria (Not applicable to already registered vendor of HOCL)

- Information regarding tenderer as stipulated in Clause.1.
- Details of work of similar type and magnitude carried out by the tenderer as stipulated in Clause.2.
- Organization chart giving details of field management at SITE, the tenderer proposes to have for this work including bio-data of the Site-in Charge and key personnel.
- In the case of MSME, necessary certificate (self attested) shall be submitted in the Technical Bid.
- The bidder should have well qualified workforce in adequate numbers for handling various stages of the work. The staff/workers details are to be furnished.
- The bidder should have adequate number of equipments/tools/tackles/staging materials in site condition for the execution of the work within the stipulated time. The equipment details should be furnished.
- Details of current commitments with copies of Work Orders to be submitted.
- Exceptions and deviations, if any, with reference to the Clause No. and page No. of Tender shall be submitted as a separate statement (Deviation Statement)
- Any other technical information the Tenderer likes to furnish.

SCOPE OF SUPPLY

Materials

a. Contractor's Scope

All materials like MS flat and square rods, (for grill only), welding rod, welding machine, cutting torch with flash back arrestor, grinding machine etc. has to be arranged by the Contractor at his cost.

Contractor has to make his own arrangements to distribute the power through ELCB/Circuit Breakers. Scaffolding if required shall be brought and erected by the Contractor at his cost.

b. HOCL Scope

In case MS channels, angles and I beams required to Reinforce the structure will be given by HOCL at free of cost. HOC will provide compressed air, water and electric power at one point.

Tools & Tackles

a. Contractor's Scope

All the tools and tackles required for the satisfactory completion of the work shall be in the scope of the contractor.

b. HOCL's Scope Nil

General Site Cleaning

Working site should always be kept cleaned up to the entire satisfaction of the Engineer/Officer-In-Charge. Upon completion of the work, all materials shall be transported to designated locations in HOCL premises as directed by the Engineer/Officer-In-Charge on daily basis. Material reconciliation has to be carried out before submitting the bill.

Time of Completion

Time of completion for dismantling, erection and painting shall be within 20 days from the date of intimation to start the work at site. However, the party can start the fabrication of the grills against LOI.

Validity of The Tender

The tender shall be kept valid for acceptance for a period of **THREE months** from the last date prescribed for receipt of the tender.

A Tenderer shall not be entitled during the said period of three months without the consent in writing of the company to revoke or cancel his tender or to vary the tendered rate or any terms thereof.

<u>Price</u>

The Contract will be awarded on fixed all-inclusive price unless otherwise specified. All rates in the tender shall cover applicable taxes, levies and duties. However applicable GST will be paid by HOCL subject to the successful tenderer having GST registration with Central Excise.

The price shall be quoted both in figures and words. In case a tenderer has quoted two different prices in words and figures the lower of the two will be considered valid and binding on the tenderer.



SUBMISSION OF BIDS: Refer Annexure I.

PRICE BID SUBMISSION-BOQ: Bidders are requested to note that they should necessarily **submit their financial bids in the format provided and no other format is acceptable.** If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. **Bidders are required to download the BOQ file, open it and complete the blue coloured (unprotected) cells with their respective financial quotes and other details** Refer Instructions to Bidder for Online Bid Submission. **(such as name of the bidder).** No other cells should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.

<u>RIGHT TO REJECT A BID</u>: HOCL reserves the right to reject any bid due to reasons such as (a) Vendor not following above bidding procedures (b) Vendor not being technically acceptable to HOCL (c) Not enclosing EMD with the techno commercial bid or EMD paid being lesser than the stipulated amount (d) Vendor not agreeing with the general conditions of the tender. (e) Not enclosing any particular documents asked for (f) Any other valid reasons.

<u>SIGNING & STAMPING ON ALL PAGES OF BIDS</u>: The vendor shall sign and stamp on all the pages of the bids uploaded, failing which bids are liable to be rejected.



- 17. The quantity shown in the schedule of rate can increase or decrease of which the Contractor should be ready. But the rate will be same throughout the pendency of work.
- 18. All the fabricated Grills (platforms) has to be painted with one coat of epoxy primer & one coat of coal tar epoxy finish after proper surface preparation. (Surface preparation should be as per SSPC-SP-2-63).

DFT - a. Primer - 1 (33 + 3) b. Finish - 1 (90)

Total DFT of all two coats - 123 microns (min)

- 19. The contractor has to make arrangement to paint the grills (platform) after welding with one coat of epoxy primer& one coat of coal tar epoxy finish in the welded portions.
- 20. All other structural's has to be painted with One coat of Zinc Phosphate Epoxy Primer & Two coats of Epoxy finish paint after proper surface preparation. Surface preparation should be as per SSPC-SP-2-63

Total DFT of all two coats - 100 microns (min)

- 21. The contractor has to make arrangement to paint the other structural's after welding / cutting with One coat of Zinc Phosphate Epoxy Primer & Two coats of Epoxy finish paint in the welded portions.
- 22. Scaffolding if required shall be brought and erected by the Contractor at his cost.
- 23. The removed platform grills, plates/grating, ladder steps, all debris arising out of the job has to be segregated, weighed, transported and dumped to the yard as per the instruction of Engineer-in-Charge.
- 24. Proper material reconciliation statement has to be made and presented along with the final bill.
- 25. The paints used for the above work shall be from the following manufacturers only.

NOTE :

- 1. Erection and hot works at site can be done on clearance from Production Department, however the contractor has to complete the prefabrication works as per instruction of engineer- in-charge well in advance.
- 2. Item No.3 (Service No. 1001730) in BoQ (Bill of Quantities):- Erection of gratings is not envisaged for this item. Contractor has to supply the grating as per the above scope of work and stack safely at a place as instructed by the Engineer-in-Charge.
- 3. If the erection is not possible due to any reasons attributable to HOCL, payment will be made as per Clause No.3 (i.e. in such case, payment for the quantities will be made in the item rate for item No.3 as in pro rata basis). Balance payment will be made when the erection is completed. No LD Clause will be applicable in such case if the cause of delay is attributable to HOCL. However, if the delay is due to any reason attributable to contractor, LD will be applied by HOCL as per Tender terms.

- 1. Average annual financial turnover during the last 3 years, ending 31st March of the previous financial year, should be at least **₹5 Lakhs**. (Details of annual financial turnover to be submitted with Documentary proof).
- 2. Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:

Three similar completed works costing not less than the amount equal to **₹6.41 Lakhs.**

OR

Two similar completed works costing not less than the amount equal to **₹8.01 Lakhs.**

OR

One similar completed works costing not less than the amount equal to **₹12.82 Lakhs.**

- 3. The parties who have been blacklisted / put in holiday list or parties in respect of whom action has been initiated for Blacklisting / Holiday listing by HOCL/any government / Quasi government agencies or any PSUs shall not be considered for award of job. The tenderer should give a written declaration regarding the same.
