- 2. The estimated annual wage/Monthly Fixed salary given in the above table is calculated based on the Present Basic Pay and VDA /Monthly Fixed salary of the Temporary Employees & Temp. Consultants currently working in the Company. The increase in the salary (BP + VDA) on account of DA increases, etc. shall be taken into consideration while settling the GPA claim. As such claim settlement shall be based on the actual salary (BP + VDA)/Monthly Fixed Salary drawn by the temporary employee before the accident.
